Subject:-Appointment of State Chief Information Commissioner &
State Information Commissioners in the Telangana
Information Commission - Reg.

Under the Right to Information Act 2005, the Government of Telangana has constituted the Telangana Information Commission which is located in Hyderabad. The powers and functions of the State Chief Information Commissioner and State Information Commissioners in the TG Information Commission are as per the RTI Act,2005 as amended in 2019.

2. It is proposed to appoint State Chief Information Commissioner & State Information Commissioners in the Telangana Information Commission.
3. The Section 15(5),(6) of RTI Act,2005 and rule 13 of RTI rules 2019 provides that the State Chief Information Commissioner and State Information Commissioner:-
 - (i) Shall be a person of eminence in public life with wide knowledge and experience in law, science and technology, social service, management, journalism, mass-media or administration and governance.
 - (ii) Shall not be a Member of Parliament or Member of the Legislature of any State or Union Territory, as the case may be, or hold any other office of profit or connected with any political party or carrying on any business or pursuing any profession. It is clarified that cessation/termination of holding of office of profit, pursuing any profession or carrying any business is a condition precedent to the appointment of a person as Information Commissioner.
4. Persons who have attained the age of **65** years shall not be eligible for appointment.
5. The salary, allowances and other terms and conditions of service of the Information Commissioners shall be as per Right to Information (Term of Office, Salaries, Allowances and Other Terms and Conditions of Service of State Chief Information Commissioner, State Information Commissioners in the Central Information Commission, State Chief Information Commissioner and State Information Commissioners in the State Information Commission) Rules, 2019, as revised from time to time.
6. Persons fulfilling the criteria and interested for appointment to the post of State Chief Information Commissioner and State Information Commissioners may send their particulars in the enclosed proforma only, by Registered Post to the office of the Chief Secretary to Government, 6th floor, Dr.B.R.Ambedkar Telangana Secretariat Khairtabad, Hyderabad 500022. Last date for receiving of applications, shall be 29.06.2024 by 5.00 pm.
7. All those who have applied in response to the earlier notification dated 04.07.2023, need not apply afresh again.
